Flood Damages still being assessed, the mayor has met with a contractor and engineer. The Engineer will be talking with Insurance Adjuster.

The Village Meeting time will change to 7:00 pm starting October 10th, 2017.

Parade Permit changes are no horses allowed in the parade due to insurance coverage per policy changes. Insurance company has to submit a new policy to get more coverage so to allow horses in the future parades.

Discussion was held on setting up a meeting with Dairyland and JoCarroll power companies to discuss buying power from them at wholesale, rates could be lower than current provider (Alliant).
